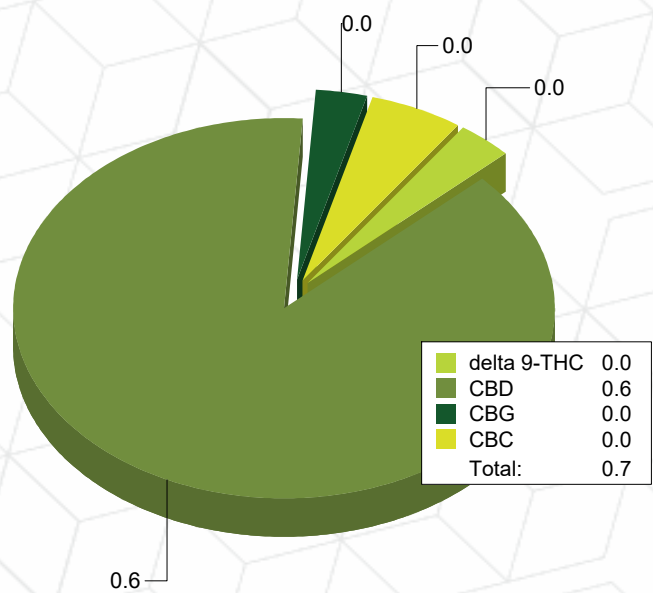

- BLI Baseline Interference - Cannabinoid peak interference in chromatographic baseline affecting QC recovery .
- BLK Analyte detected in method blank, but not associated samples.
- BSH Blank Spike High - Blank Spike recovery above method limit. no detections in samples.
- BSL Blank Spike Low - Blank Spike recovery below lower method limit, analyte chromatography reviewed manually for all samples.
- C Interference due to co-elution
- CBD Interference due to co-elution
- CV1 CBD matrix interference on GC Pest chromatography
- CV2 CCV was above acceptance criteria, Non-detect samples are considered acceptable.
